We practice all of these. Prior to Covid 19, we had communion every week. During the pandemic we have offered communion every other week.

When the Cranberry Hymnal was Introduced, we purchased enough for our congregation; however, we soon realized we were not happy with that hymnal. We sold them to another church and went back to using the green hymnal which we still use today. We also Incorporate "With One Voice" Into our worship services.

During the summer months we worship at one service in our outdoor pavilion. People have the option of sitting outside or listening to the service in their cars on an FM radio station.

At one time we had an active bell choir.

Describe your congregation's Christian education ministry.

Much of our education ministry Is focused on adults. At one point we had four adult Sunday School Classes. As in a lot of churches, we find a lapse of Sunday School and church attendance between confirmation and young married couples. Once confirmed, it seems that the parents lack the necessity of bringing their teenagers to Sunday School and Church. Many outside activities take priority over worship.

Our faith Is strong. Our efforts are strong. Financially, problems that occurred over the past 4 to 5 years have limited our mission and outreach. At the present time we support Fresh Express, Flood Buckets, Water Missions, A community New Year's Day Dinner, local and foreign missions.

We suffered a temporary hardship due to having had money embezzled from our weekly Income.

Our financial problem is being resolved because the congregant who misappropriated money from St. Paul has agreed to repay the amount in full. The discovery was made in 2020. Many hours were spent in investigating the full extent of the misappropriation. An accountant was hired to give us support and direction and finally the crime was turned over to the police. In March 2021 the congregant was arrested and the case has been settled as of August 18, 2021. We have offered forgiveness to the congregant and invited him to return to St. Paul if he so desires.
