The 2018 Convocation was called to worship by Rev. Ken Hohag. Rev. John Bradosky, NALC Bishop, presided over the service and the Rt. Rev. Charles Masters, ACNA Diocesan Bishop preached.

3:00pm

Call to Order

Rev. Bradosky, called the Convocation to order and declared a ten-minute recess.

Dr. Schwarz shared highlights of the work done by the Board of Regents this past year: developed sabbatical policy for seminary faculty, ethical misconduct statement for non-clergy and clergy faculty and conflict of interest statement that members of the board have signed. Dr. Schwarz explained the five-year plan for Rev. Dr. Schifrin to step down as president of the NALS into a faculty role. Rev. Dr. Schifrin introduced Father Aiden Smith, Trinity School for Ministry Dean of Advancement and Director of Partnerships. Father Smith thanked the NALC for their partnership. Rev.
